Our #1 Legislative Priority

H.R.38 - Concealed Carry Reciprocity Act

- Sponsored by Rep. Hudson (NC-09), this bill allows an individual who is able to carry a concealed firearm in one state to carry or possess a concealed handgun (other than a machine gun or destructive device) in another state that allows its residents to carry concealed firearms.
- USCCA For Saving Lives Action Fund believes the right to keep your firearm on hand shouldn't stop at just your home or property. Your right to defend yourself and your family shouldn't disappear because of geography it should be honored wherever you go.
- Companion Bill S.65 Concealed Carry Reciprocity Act, introduced in the Senate by Senator Cornyn.





H.R. 223 - Preventing Unjust Red Flag Laws Act

Sponsored by Rep. Crenshaw (TX-02), this bill prohibits the use of federal funds to implement or enforce red flag laws. The term red flag law references an order that allows firearms to be temporarily removed from a person's possession if the person is believed to be a danger to themselves or others.

This bill provides a prohibition on funding in two ways:

- 1. Funds made available for any Federal department or agency may NOT be used to implement or enforce Federal red flag laws or
- 2. provide assistance to States, local, tribal, or territorial government departments or agencies for the implementation or enforcement of red flag law
- USCCA For Saving Lives Action Fund believes that his legislation is a step in the right direction by ensuring federal funds are not used to implement red flag laws which we fundamentally oppose.

I H.R. 1643 - Age 21 Act

- Sponsored by Rep. Thomas Massie (KY-04), this bill would lower the minimum age to purchase a large-capacity ammunition feeding device or semiautomatic assault weapon from 21 to 18 years of age.
- USCCA For Saving Lives Action Fund believes that this bill would help individuals between 18-20 years old to protect themselves and their families.



H.R. 45 - Firearm Industry Nondiscrimination (FIND) Act

- Sponsored by Rep. Bergman (MI-01), this legislation will end the ability of corporate entities to profit from taxpayer-funded federal contracts while discriminating against a Constitutionally-protected industry at the same time.
- USCCA For Saving Lives Action Fund believes in freedom of speech, and while corporations may hold anti-Second Amendment positions they should then forfeit access to lucrative federal contracts

H.R. 1224 – Protecting the 2nd Amendment in Financial Services Act

- Sponsored by Rep. Andrew Ogles (TN-05) to prohibit the use of a merchant category code that separately identifies firearms merchants or ammunition merchants, and for other purposes.
- USCCA For Saving Lives Action Fund believes that this bill will protect the privacy of American purchases in regards to firearms and ammunition.





H.R. 70 - No SmartPay for Anti-2A Companies Act

- Sponsored by Andy Biggs (AZ-05), this legislation will prohibits the General Services Administration from awarding a contract under the SmartPay Program for the procurement of a commercial payment system that uses a payment processing agency that has implemented a merchant category code for gun retailers.
- USCCA For Saving Lives Action Fund believes every responsible gun owner should be able to privately purchase firearms to protect their loved ones - without unfair financial tracking or discrimination.

H.R. 563 - No Retaining Every Gun In a System That Restricts Your Rights Act

- To amend title 18, United States Code, to discontinue the collection by the Federal Government of firearm transaction records of discontinued firearms businesses, to require the destruction of such already collected records, and for other purposes. Sponsored by Rep. Michael Cloud (TX-27)
- USCCA For Saving Lives Action Fund believes that gun owners should have their privacy respected in respects to firearms purchased from discontinued businesses.



Legislative Priorities - Oppose

S.597

- Sponsored by Sen. Alex Padilla (D-CA) A bill to amend Title 18, United States Code, to prohibit the purchase of certain firearms by individuals under 21 years of age, and for other purposes.
- USCCA For Saving Lives Action Fund believes that this would leave individuals from 18-20 years old unable to protect themselves and their families. It is unconstitutional to deprive these young adults of their Second Amendment rights.



H.R. 1307 - To Establish the Office of Gun Violence Prevention

- Sponsored by Maxwell Frost (FL-10), this bill would establish the Office of Gun Violence Prevention.
- USCCA For Saving Lives Action Fund believes America deserves firearm organizations that protect their Second Amendment rights rather than stripping them away

S.889

- Sponsored by Sen. Richard Blumenthal (D-CT) A bill to support State, Tribal, and local efforts to remove access to firearms from individuals who are a danger to themselves or others pursuant to court orders for this purpose.
- USCCA For Saving Lives Action Fund believes that this bill is similar in purpose to red flag laws, removing firearms from citizens with little oversight into their Second Amendment rights.

I am writing to you today with strong support for the Firearm Industry Nondiscrimination (FIND) Act that has been introduced in the United States House of Representatives as H.R. 45 and urge you to vote YES if this bill is brought to the House floor for a vote.

This legislation will end the ability of corporate entities to profit from taxpayer-funded federal contracts while discriminating against a Constitutionally-protected industry. No longer will corporations be able to deny citizens access to their Second Amendment rights while profiting from tax-payer-funded contracts.

This legislation does not tell companies with whom they must do business. However, just as companies can choose who they wish to do business with, so can the government when it spends taxpayer money.
